	applicant must ensure that the equipment is functioning properly before delivery. A pair of extra batteries, charging cables/power cables, operating manual and previous calibration certificates (if any) must also be provided.									
*	The equipment must be handed over to EM&D Lab (PNRA) on the appointment date as communicated through letter or email.									
*	Prior payment of calibration charges is mandatory before equipment collection. The calibration charges must be									
	paid in the form of a Bank Draft / Bankers Cheque in favor of the "Director Finance, PNRA" at the time of equipment collection.									
*	In the case of courier/shipping, the applicant is solely responsible for all associated charges. EM&D Labs (PNRA)									
	will bear no liability. Additionally, EM&D Labs will not be responsible for any damage to or loss of the equipment									
*	incurred during shipping.  If the equipment is found to be not responding during the calibration process, calibration fees will still be charged.									
·		However, EM&D Labs, PNRA, will not be liable for any damage claims regarding the equipment.								
*		The equipment must be collected by the applicant within 10 working days of the communicated collection date. EM&D Lab will not be liable of any damage/loss in case the equipment is not collected back within this timeframe.
