5. TERMS & CONDITIONS

Following are the terms and conditions for availing services of radiometric analysis of edible and non-edible items:

- The applicant must ensure that all information provided in the application form is complete, accurate, and includes detailed particulars of the firm, items, type of analysis, and any other relevant details; failure to do so may lead to rejection or delay in the analysis of the item.
- Charges will be based on type of analysis required as defined in PNRA regulations PAK/900 (current applicable revision available at www.pnra.org).
- Payment is required to be made via Pay Order/Bank Draft in favor of "Director Finance PNRA" along with the application. No item will be analyzed until full payment is received.
- Each sample of the item must meet minimum quantity requirement i.e. two (02) liters for liquids and three (03) kg for solids and shall be used for one analysis only. Separate samples of the same minimum quantity are required for every additional analysis.
- Items must be packaged and labeled according to applicable industrial safety standards. Improperly packaged or unlabeled items will not be accepted for analysis.
- Results will be communicated within 15 working days after receiving item subject to complete application form.
- All analyzed samples will be retained with the EM&D Labs for a maximum period of three (03) months. However, samples containing perishable items will be retained for only one (01) month after analysis.
- The results pertain exclusively to the samples of the items submitted by the applicant. EM&D Labs bears no responsibility for the remainder of the shipment.
