#### NOTIFICATION

Islamabad, the 30th December, 2023

**S.R.O. 1922(I)23.**—In exercise of the powers conferred by Section 16(2)(a) read with Section 56 of the Pakistan Nuclear Regulatory Authority Ordinance, 2001, the Pakistan Nuclear Regulatory Authority is pleased to promulgate the following regulations:

1. Short Title, Extent and Commencement.—(1) These regulations may be called "Regulations on Licensing Fee by Pakistan Nuclear Regulatory Authority - (PAK/900) (Rev.4)".

(2) These regulations extend to the whole of Pakistan.

(3) These regulations shall come into force at once.

2. **Definitions.**—(1) In these regulations, unless there is anything repugnant in the subject or context,

- (a) "*applicant*" means a person as defined in the Ordinance who applies to the Authority for a license or an authorization;
- (b) "facilities and activities" means a general term encompassing nuclear facilities, uses of all sources of ionizing radiation, all radioactive waste management activities, transport of radioactive material and any other practice or circumstances in which people may be subject to exposure to radiation from naturally occurring or artificial sources;
  - (i) "facilities" include nuclear facilities; irradiation installations; some mining and raw material processing facilities such as uranium mines; radioactive waste management facilities; and any other places where radioactive material is produced, processed, used, handled, stored or disposed of or where radiation generators are installed on such a scale that consideration of protection and safety is required.
  - (ii) "activities" include the production, use, import and export of radiation sources for industrial, research and medical purposes; the transport of radioactive material; the decommissioning of facilities; radioactive waste management activities such as the discharge of effluents; and some aspects of the remediation of sites affected by residues from past activities.
- (c) "*licensee*" means the holder of valid license issued by the Authority; and
- (d) "special form radioactive material" means either an indispersible solid radioactive material or a sealed capsule containing radioactive material.

(2) All other words and expressions used in these Regulations but not defined shall have the same meanings as defined in the Ordinance.

3. Interpretation.—The decision of the Chairman regarding interpretation of any word or phrase of these regulations shall be final and binding.

4. General.—(1) Under the provisions of Section 56(2) of the Ordinance in connection with licensing and regulatory functions, the fee charged by the Authority is commensurate with the nature of the facility or activity applying graded approach and the regulatory efforts involved.

- (2) Fee and Charges.— The fee and charges are described below:
- (a) License and Authorization Fee. The applicant or licensee requiring license or authorization for a facility or activity shall submit an application as required by relevant PNRA regulations along with fee prescribed in Schedule I and Schedule II of these regulations.
- (b) Annual Renewal Fee.—The licensee shall pay annual renewal fee as prescribed in Schedule I of these regulations.
- (c) Acquisition License Fee.—The applicant or licensee requiring acquisition license for radiation sources for a facility or activity shall submit an application as required by relevant PNRA regulations along with acquisition license fee. The acquisition license fee shall be similar to the applicable license and authorization fee category as per Schedule I of these regulations. Similarly, if the acquisition license deems to be renewed as per relevant PNRA regulations then the acquisition license renewal fee shall be equal to the applicable annual renewal fee category as per Schedule I of these regulations.
- (d) Revalidation Fee.—Under the provision of other relevant Regulations issued by the Authority, the licensee shall apply for revalidation of certain types of License and Authorizations along with the revalidation fee as prescribed in Schedule I of these regulations.
- (e) Surcharge on Late Payment of Fee.— If licensee fails to pay annual renewal fee prior to the expiry date of license, the fee payments shall be made as follows:

i.	Annual Renewal Fee credited to PNRA account within three (03) months after the expiry of license	Annual renewal fee + 10% of the renewal fee as surcharge
ii.	Annual Renewal Fee credited to PNRA account between three (03) to six (06) months after the expiry of license	Annual renewal fee + 15% of the renewal fee as surcharge
iii.	Annual Renewal Fee credited to PNRA account later than six (06) months after the expiry of license	Annual renewal fee + 25% of the renewal fee as surcharge

- (f) License or Authorization's Transfer and Amendment Fee.—A licensee requiring transfer, amendment or changes in the license or authorization shall deposit a fee prescribed in Schedule III of these regulations.
- (g) Service Charges.—Under the provision of Section 56(2)(b) of the Ordinance, the Authority may provide services if requested by the applicant or licensee. The types of services and their corresponding fee are addressed in Schedule IV of these regulations. In case of any service not enlisted in Schedule IV of these regulations, the applicant or licensee shall pay all cost as mutually agreed by the applicant or licensee with the Authority.
- (h) Expert Consultation Expenses.—In performing its licensing and regulatory functions by the Authority where consultation of an external expert is necessary, the applicant or licensee shall pay all cost as mutually agreed by the applicant or licensee with the Authority.

(3) **Payment of Fee.**—Each application for which fee and charges are prescribed shall be accompanied by a remittance for the full amount of fee or as agreed with the Authority in favor of "Director (Finance), PNRA, Islamabad".

(4) Non-Payment of Fee.—The cases of non-payment of fee shall be dealt as per Section 44 of the Ordinance and PNRA Enforcement Regulations - (PAK/950).

(5) Increase in Fee.—An annual increase of 10% shall be applicable in the annual renewal fee for nuclear power plant operating license fee as tabulated at Sr No. A(1)(b) of Schedule I of these regulations.

5. **Repeal.**—The "Regulations on Licensing Fee by Pakistan Nuclear Regulatory Authority - (PAK/900) (Rev.3)" notified vide S.R.O. 544(1)/2020 dated 15th June, 2020 is hereby repealed.
